

HOLD HARMLESS AGREEMENT THROUGH ENTRY INTO COMPETITION

In consideration for allowed entry into and participation in all activities associated with the Miss World Ethiopia pageant, and the Konjo International, Inc. (collectively, MWE&KI), I RELEASE, INDEMNIFY AND HOLD HARMLESS, MWE&KI, their present and former officers, directors, members, staff, sponsors and agents from all claims, loss or damage that may accrue to me as a result of entry into and participation thereof.

RELEASE FROM LIABILITY: In consideration described in this agreement, I hereby RELEASE and WAIVE any claim against MWE&KI, their present and former officers, directors, members, staff, sponsors and agents for damages or injuries, and agree not to sue the MWE&KI. I further agree that MWE&KI shall not be liable to me, my family, or my guests, for personal injury, property damage, or any other losses. I understand that this Release and Indemnity Agreement shall be binding on my heirs, executors, successors and assigns.

This release agreement includes, but is not limited to losses caused by any of the following: NEGLIGENCE, GROSS NEGLIGENCE, NEGLIGENCE PER SE, and/or STRICT LIABILITY, of MWE&KI.

AGREEMENT TO INDEMNIFY AND HOLD HARMLESS: In further consideration described in this agreement, I agree to INDEMNIFY and HOLD HARMLESS, MWE&KI their present and former officers, directors, members, staff, sponsors and agents, and any other person, firm, or corporation bound to defend or pay judgments against them, for any and all losses, claims, demands, or causes of actions, costs of defense or settlement, including bodily injury or death caused by NEGLIGENCE, GROSS NEGLIGENCE, NEGLIGENCE PER SE, STRICT LIABILITY and/or LIABILITY under MWE&KI or whatever other reason. Specifically, I agree to INDEMNIFY MWE&KI, including costs of defense or settlement, for any liability to a minor under my care and control and/or his or her parent/guardian due in the NEGLIGENCE, GROSS NEGLIGENCE, NEGLIGENCE PER SE, STRICT LIABILITY, or any act or omission of MWE&KI and/or other persons. TO INDEMNIFY means to agree to assume the liability in a situation thereby relieving the other party of responsibility.
